

## SUPPLY CHAIN MANAGEMENT IMPLEMENTATION REPORT FOR JANUARY 2024

1. In terms of Chapter 1 – paragraph 6(4) of the Councils Supply Chain Management Policy: "The Accounting Officer must within 10 days of the end of each quarter, submit a report on the implementation of this policy to the Executive Mayor." Paragraph 6(5) further states that: "The aforesaid reports must be made public in accordance with section 21A of the Municipal Systems Act."

## 2. STATISTICAL INFORMATION:

2.1 DEMAND MANAGEMENT – The SCM Unit, with the support of the Chief Financial Officer has submitted a list to all Directorates that requires timely planning and management processes to ensure that all goods and services which are required are quantified, budgeted, and delivered in a timely manner at critical delivery dates, so that the budget can be dealt with as per the cash flow statements.

This Demand Management Plan will be used as a strategic tool to implement the budget. The Demand Management Plan will assist the SCM Unit and user departments with the planning of the execution and timely completion of projects in alignment with the performance targets in the Service Delivery and Budget Implementation Plan.

The new Procurement plan was distributed to all departments, and they needed to submit their specifications early as indicated in the procurement plan. Each Department will report on their own procurement dates and processes monthly and at the end of each quarter the Finance Department will report overall on all departments.

The legislation on procurement has changed as has been Gazette in Government Gazette 49863 on 14 December 2023.

## 3. MONTHLY REPORT ON DEVIATIONS AND MINOR BREACHES

The Municipal Supply Chain Management Regulations - Gazette 27636 0f 30 May 2005, states in Section 36 "

- (1) A supply chain management policy may allow the accounting officer
  - a) To dispense with the official procurement process established by the policy and to procure any required goods or services through any convenient process, which may include direct negotiations, but only
    - i. In an emergency
    - ii. If such goods or services are produced or available from a single provider only.
    - iii. For acquisition of special works of art or historical objects where specifications are difficult to compile.
    - iv. acquisition of animals for zoos; or
    - v. in any other exceptional case where it is impractical or impossible to follow the official procurement process; and
  - (b) To ratify minor breaches of the procurement process by an official or committee acting in terms of delegated powers or duties which are purely of technical nature.
- (2) The accounting officer must record the reasons for any deviations in terms of sub regulation (1) (a) and (b) and report them to the next meeting of the council, or board of directors in the case of a municipal entity and include as a note to the annual financial statements.

### 1. PURPOSE

To obtain approval in terms of Regulations 29 (1) (a) and (b) (l) of the Municipal Supply Chain Management Regulations and paragraph 29 of the Bergrivier Municipal Supply Chain Management Policy, for the appointment of an accredited service provider to render background screening, vetting and criminal checks for Bergrivier Municipality for a period of thirty-six (36) months.

#### 2. BACKGROUND

It is the objective of Bergrivier Municipality to procure the services of an accredited service provider to render background screening, vetting and criminal checks for Bergrivier Municipality for a period of thirty-six (36) months. The general intent of this contract is that the service provider shall provide all resources necessary for the supply of goods/services in accordance with the terms of the Contract.

### 3. DISCUSSION

The tender was advertised on Friday, 20 October 2023 in "The Burger" and "The Cape Times" Newspapers, the Municipal website, and Notice Boards, based on 80/20 Preference Point System. The tender closed on Wednesday, 22 November 2023 at 12h00. The tenders received were opened by representatives of Bergrivier Municipality and are valid for 120 days after the closing date. ### 4 TENDER DISCUSSION

### Tenderers not considered for further evaluation:

4.1 Name: Search works 360 (Pty) Ltd

Reason:

• The tender specifications state that the proposed Service Level Agreement must be attached to the tender, but the agreement is not attached to the tender as requested.

- Tenderer also did not tender for the following services:
  - Permanent Residence Permit
  - > Work Permit
  - SAQA Certificate Verification
  - Institution accreditation
  - Driver Accident History
  - Reference check (SA)
  - Character Reference & Proof of Employment (SA)
  - Verify Professional Association Memberships (SA)
- According to GENERAL CONDITIONS OF TENDER on p19 of the tender document, under point 2.3, it clearly states that "Documents may only be completed in non-erasable ink". The tender notice also states in the last paragraph that "Only bids completed in black ink on the original Bid documentation will be accepted." The specifications also clearly indicated the abovementioned condition. The tender document was completed and signed electronically.

### 4.2 Name: Gijima Holdings (Pty) Ltd

Reason:

- Tenderer did not attach a copy of the proposed Service Level Agreement as requested as part of the specifications.
- Pricing schedule with fees for additional services provided by the tenderer, not submitted as part of tender.

  - Sanctions
  - Judgement listing Individual
  - Registration check (Other)
  - > Additional fee for queries not registered with provider.

• The Tenderer responded by referring to the page numbers in the tender regarding the pricing and submitted the pricing schedule with the e-mail. SCM report for the month of January 2024

### 7. RECOMMENDATION:

The following recommendations applicable to this tender are made:

- That tender 8/3/37-2023 (MN204/2023) for the Appointment of an Accredited Service Provider to render Background Screening, Vetting and Criminal Checks for Bergrivier Municipality for a period of Thirty-Six (36) Months, as set out in the tender document, be awarded to Nexus Forensic Services (PTY) LTD as per the rates set out in the tender document, for a period of thirty-six (36) months within the available budget; and

## 6. APPEALS / OBJECTIONS BY AGGRIEVED
