Quotations in sealed envelopes clearly marked "**QUOTATION MN2/2012: Hiring of bulldozer to clear the waste dumping sites**" must be deposited in the tender box at the municipal Offices, 13 Church Street, Piketberg before **12:00** on **FRIDAY, 17 February 2012**, when quotations will be opened in public.

Quotations will be evaluated according to Council's Supply Chain Management Policy. It is thus compulsory to complete the requisite documents of the Preferential Procurement Regulations to qualify for preference points. Prices must include VAT.

A valid and original tax clearance certificate issued by the South African Revenue Services (SARS) must accompany quotations.

Quotations other than Exempted Micro Enterprises (EME'S) must be accompanied by a valid BBEE- verification certificate or a certified copy thereof. Enterprises with an annual turnover of less than R5 million must obtain an Exempted Micro Enterprise certificate from a registered auditor or accounting officer confirming their annual income.

Tenderers must qualify to register as a prospective supplier on Council's data base.

Late, incomplete or quotations received by fax will not be accepted. Proof of dispatch of a quotation will not be regarded as proof of receipt thereof. Council is not obliged to accept the lowest or any quotation. Council reserves the right to accept any quotation or part thereof.
