Bergrivier Munisipaliteit het op Vrydag, 3 November 2023 die sleutels van splinternuwe huise aan 4 begunstigdes van die St. Christopher/Proteastraat behuisingsprojek in Velddrif oorhandig. Die begunstigdes is Beatrice Liebenberg, Elizabeth Amerika, Amanda Blaauw en Marlene Salmoen.

Die Munisipaliteit het hierdie huise eers gesloop en toe weer herbou teen 'n bedrag van R3 miljoen, as gevolg van die swak toestand van die geboue.

Die Behuisingspersoneel van Bergrivier Munisipaliteit is tans besig met die oordragproses ten einde eienaarskap aan die begunstigdes te voltooi.

Marlene Salmoen (65), die oudste van die begunstigdes, sê sy is baie dankbaar vir hierdie nuwe huis en dank die Here daarvoor. "Ek het 20 jaar gewag vir hierdie huis. Dit voel onwerklik en ek kan eintlik nie beskryf hoe gelukkig ek voel nie. Ek is ewig dankbaar vir God en Bergrivier Munisipaliteit vir hierdie geleentheid," het Salmoen gesê.

Haar boodskap aan ander inwoners wat op 'n huis wag is: "Wees geduldig en ook redelik. God sien, hoor en erken jou omstandighede en noodkrete, maar slegs op Sy tyd sal dinge vir jou beter word. Hou moed," het Salmoen afgesluit.

Die sloping en herbou van vier huise in (Sandstraat) Piketberg sal in 2024 'n aanvang neem.

# BERGMUN BEMAGTIG 27 PLAASLIKE ENTREPRENEURS BY WERKSWINKELS

Bergrivier Munisipaliteit se Finansiële Departement het in November 2023 werksinkels in Piketberg, Porterville en Velddrif gehou, om opkomende mikro-ondernemings te bemagtig om besigheid met die munisipaliteit te kan doen.

'n Totaal van 27 plaaslike entrepreneurs het die werksinkels bygewoon. Nelmarie Bothma, Bestuurder: Uitgawes en Voorsieningskanaalbestuur en waarnemende hoof finansiële beampte, sê die hoofdoel van hierdie inisiatief is om plaaslike besighede te help om nie net besigheid te doen met die munisipaliteit nie, maar ook om 'n beter begrip te hê van die volledige voorsieningskanaalbestuur proses.

“Ons wil plaaslike ondernemings bemagtig met alle belangrike inligting oor hul belasting sake en enige navrae oor die voltooiing van formele kwotasies of tenders. Ons wil graag hê dat meer plaaslike besighede registreer op ons Sentrale Verskaffer Databasis. Dit is uiters belangrik, aangesien dit die eerste stap is om besigheid te doen met die munisipaliteit en plaaslike ekonomiese ontwikkeling te verseker”.

- “Tenders en formele kwotasies is oop vir die publiek en dus moedig ons alle plaaslike entrepreneurs aan om proaktief te wees en inisiatief te neem om aansoek te doen by die munisipaliteit vir besigheid,” het Bothma gesê.

# PIKETBERG BUSINESS CHAMBER ESTABLISHED

On 25 October 2023, Bergrivier Municipality hosted various business stakeholders operating in Piketberg at the local museum, to establish a business chamber.

The Municipality's Strategic Services Department led a high-level discussion with the representatives from the business sector, with a firm focus on partnering, sharing ideas and planning towards a better future for the town and its citizens, Alletta van Sittert, Manager: Strategic Services, mentioned that without the business sector's involvement in the planning processes of the Municipality, the needs of the business sector will not be known, which will hinder all efforts to create an enabling environment for economic growth.

A total of 21 sector representatives attended the inaugural inception meeting, to establish the Piketberg Business Chamber (PBC). All guests were welcomed by Alderman Riaan de Vries, Mayoral Committee Member at Bergrivier Municipality. De Vries reminded everyone of the important role businesses play in driving socio-economic development within the area. In addition, De Vries encouraged business owners to engage the Municipality during its planning processes like with the 5 year strategic plan called the Integrated Development Plan (IDP); the Spatial Development Framework that is drafted and revised every 5 years (SDF), and the annual municipal budget. The entire engagement was facilitated by Mr. Johnny De Silva, chairperson of the Velddrif Chamber of Commerce.

Van Sittert is also the Bergrivier champion of the national Small-Town Regeneration Programme, of which Bergrivier Municipality has been identified to participate in, with a specific focus on Piketberg. The Small-Town Regeneration programme will bring about various infrastructural, economic, and social development improvements, however, it will need the business sector to complement these enhancements within Piketberg.

In conclusion, eight people were nominated to form the core membership of the PBC.

The 36th annual Fish Factory Tournament was held in October 2023 at the Eric Goldsmith Sports grounds in Velddrif.

More than 5 000 spectators pitched to support their favourite local teams in various sporting codes such as rugby, netball and soccer. The two-day tournament, which was organised by Boland Rugby Union in collaboration with Bergrivier Municipality, was the brainchild of the late Dr. Danie Craven and it aims to provide players working in the fishing industry an opportunity to showcase their talents. The first fish factory tournament was held in Saldanha Bay in 1987.

The atmosphere inside the stadium was electrifying, especially since this tournament took place on the weekend of the Rugby World Cup Final. Various dignitaries from Boland Rugby Union, including the President Mr. Bennie van Rooy, were present at the tournament as well as special guests from Bergrivier Municipality such as the Executive Mayor Alderman Ray van Roy and the Director of Community Services, Dean Josephus.

This year's tournament featured 14 rugby teams from various fish factories and phenomenal rugby was on display throughout the weekend. Elands Bay B was crowned as champions after beating last year's winners, Gansbaai Abalone, 25-15. The best performing players from the different teams at this tournament will be given an opportunity to compete against a Top 12 Boland rugby team, allowing deserving players to gain more exposure.

There was action-filled netball for spectators throughout both days, Sea Vuna, I&J and Sea Harvest were respectively crowned the winners of the three netball categories.



# BERGRIVIER WELCOMES NEWLY APPOINTED HEAD: FACILITIES MANAGEMENT

“Expanding and enhancing our facilities and services to reach world class standards is a goal of mine. We want to build positive relations with all our residents, so that they feel proud of their facilities and take ownership of it”.

So says Tyrone April, who had recently been permanently appointed as the new Head: Facilities Management with the Community Services Directorate at Bergrivier Municipality. He assumed office as of 09 October 2023.

His role as the new Head: Facilities Management is to ensure the operational oversight over all community halls, resorts, swimming pools, public open spaces and cemeteries. Keeping the strategic goals and the vision of the Municipality in mind, April stressed the importance of creating public spaces and facilities which residents will take pride in and, in effect, blow the whistle on vandalism by reporting incidences immediately.

Tyrone April (35), born in Paarl, matriculated at Outeniqua High School in George in 2005. He obtained his National Diploma in Nature Conservation in 2014 at Nelson Mandela University (George Campus).

Some of the highlights of his career includes his experience gained at Sanparks where he worked as a Section Ranger at Table Mountain for three years. He was involved in the management of “one of the seven wonders of nature”. According to April, this site has deep cultural significance for the indigenous Khoi-San people. They refer to Table Mountain as “Hoerikwaggo”, which means “mountain in the sea”. April also worked for four years at George Municipality as a Superintendent: Parks & Recreation. At this Municipality, he and his team achieved full blue flag status for their beaches in 2021. They didn't only manage to keep that status, but rather expanded it to another two beaches.

Outside of his professional life, April is a very active and energetic person. Some of his hobbies include fishing, cycling, canoeing and hiking.

He mentioned that he'd like to contribute to creating a safe, clean and green environment for communities within the Bergrivier Municipal Area. “The sense of community that I have experienced thus far is gratifying and something I wish to add to and build upon. There is so much to be proud of and thankful for, we can only grow together going forward,” he concluded.




# BERGRIVIER WELCOMES NEWLY APPOINTED HEAD: STRATEGIC SERVICES

“Do the ordinary things, extraordinarily well”.

These were the words of the newly appointed Head: Strategic Services of Bergrivier Municipality, Adrian Kearns, who assumed office as of 04 September 2023.

Kearns mentioned that his vision is to build sustainable medium to long term partnerships for greater impact not only in the Bergrivier Municipal Area, but the West Coast as a whole. Another important goal for him is to develop the ‘people’s Integrated Development Plan’ and the ‘people’s Spatial Development Framework’, as well as their municipal budget. “Communities should be able to easily understand these very important terms and strategic plans, because it has a significant impact on their lives,” said Kearns.

Adrian Kearns (40), originally from Cape Town (Hanover Park), attended Blomvlei Primary School in Hanover Park. He matriculated at Alexander Sinton High School in Crawford and later on completed his BTech in Public Management at the Cape Peninsula University of Technology (CPUT) in 2013.

Kearns referred to the fact that the country’s current National Development Plan is nearing its end in 2030. “As various governmental institutions in South Africa, it is our collective goal to operationalize this plan into a strategy, whether it be at local, provincial or national level,” explained Kearns. On a local government level, a Municipality’s Integrated Development Plan (IDP) and its Spatial Development Framework (SDF) forms the very foundation for its strategic direction. Without the necessary budget, collaborations, partnerships and agreements in place, a strategy cannot be implemented.

At the age of 20, Kearns entered the formal sector as an Admissions Clerk at Hanover Park Community Health Centre. Over the next fifteen years, he worked at various government departments. Some of the highlights of his career includes managing two multi-million rand projects (National Treasury Projects) namely, Vulekamali and Municipal Money, both data portals. He has been extremely blessed to have worked in the most remote areas of the Western Cape such as Merweville, Klaarstroom, Vanrhynsdorp, Bella Vista and Kouebokkeveld, to educate and transfer his skills and knowledge. In times where resources were immensely scarce, he was able to translate strategic plans into realistic and measurable operational plans.

He is also a very active and energetic person and still plays cricket for Hanover Park Cricket Club. In his spare time he attends bible college to deepen his faith. Kearns loves cooking and mentioned that he and his wife actually won first place on the Kom Ons Braai TV show a few years ago. Most importantly, he loves spending time with his sons Bailey (4) and Keaton (14).

“This is how I do everything in life, extraordinary, even if it’s just a simple thing I always ask myself ‘How do I make what I do, stand out?’. Bergrivier is a beautiful area and has many similarities to other rural municipalities. In those similarities, you will find extraordinary opportunities in the very ordinary activities taken on by local residents. Whether it’s dancing, sports, culinary, services, culture and language, we need to explore the opportunities that have enormous potential more and be proud of it. Let’s love our neighbour as ourselves and demonstrate the extraordinary values we have in common,” he concluded.

## AMENDMENT OF THE SPATIAL DEVELOPMENT FRAMEWORK FOR THE BERGRIVIER MUNICIPALITY

Bergrivier Municipality is revising the Municipal Spatial Development Framework (SDF), in terms of the Spatial Planning and Land Use Management Act, 2013 (Act 16 of 2013) ('SPLUMA'), the Western Cape Land Use Planning Act, 2014 (Act 3 of 2014) ('LUPA') and the Bergrivier Municipality Land Use Planning By-Law (PN 8365 of 11 December 2020) ('By Law').

It is critical to note that Section 12(5) and (6) of SPLUMA states that:

*“12(5) A municipal spatial development framework must assist in integrating, coordinating, aligning and expressing development policies and plans emanating from the various sector of the spheres of government as they apply within the municipal area.*

*12(6) Spatial development frameworks must outline specific arrangements for prioritising, mobilising, sequencing and implementing public and private infrastructural and land development investment in the priority spatial structuring areas identified in spatial development frameworks.”*

Bergrivier Municipality has opted to establish an Intergovernmental Steering Committee (ISC) and the requirements of section 6 of the By-Law and section 12 of LUPA, are therefore applicable. The process thus far has included the registration of interested and affected parties, compilation and adoption of the Status Quo Document and completing a **first draft of the new 5-year Municipal Spatial Development Framework (MSDF) 2024 – 2029**.

The MSDF has reached a critical stage whereby the community, general public, interested and affected parties are hereby, in terms of the Municipal Systems Act, No. 32 of 2000 ("MSA"), invited to submit written comments, inputs and/or recommendations on the revised MSDF 2024 – 2029. In accordance with Section 12(4) of LUPA and Section 6 (4) of the By-Law, formal comment is requested from the Provincial Minister and the public.


