

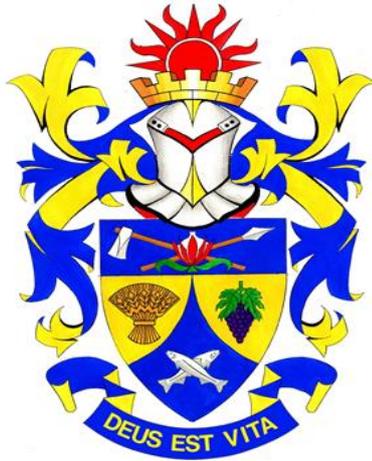

Raadsheer De Vries meld dat stellings gemaak was tydens 'n onlangse Gemeenskapsveiligheidsvergadering dat daar geen samewerking is tussen Wetstoepassing en die Suid-Afrikaanse Polisie dienste nie.

The Municipal Manager requested that the discussion be conducted in English to accommodate the English-speaking officials in attendance.

The Director Community Services expressed concern at the statement of Alderman De Vries and highlighted that the incidents recorded through the Active Box are reported on a quarterly basis.

As a point of clarity, Alderman Wessels highlighted that communication within SAPS itself is scattered. He mentioned an example of radios in Police Stations which are put on silent resulting in communication by telephone. He further mentioned that SAPS sends juniors to attend Community Policing Forums but they do not actually know how it works and make statements such as the one under discussion. Alderman Wessels undertook to take this matter up with the relevant authorities.

- The Speaker enquired when last an incident report was received regarding visits by Law Enforcement to the homes of the Executive Mayor and Executive Deputy Mayor, whereafter he requested to be provided with the reports;
- That the Speaker is still awaiting the bodycam footage of the Council meeting held in Eendekuil on Tuesday 27 May 2025; and
- That the need for Councillor safety is going to escalate and called for cool heads and leadership when engaging in discussions. The Speaker furthermore requested that Alderman Wessels take the lead and finalise this aspect.

Alderman Wessels mentioned that the Director Community Services had already requested a meeting earlier in the week and undertook to have the aspect resolved with the Speaker by end of day on Tuesday 24 June 2025.

The Municipal Manager responded as follows to various aspects of the discussion:

- That the bodycam footage was provided to the Speaker and Municipal Manager by e-mail on Friday 30 May 2025;
- That a letter was delivered on Monday 23 June 2025 to the individual who disrupted the Council meeting on Tuesday 27 May 2025;
- That Protection Services is not on the current macro-organogram and an item will be brought by the Municipal Manager to Council along with approximately seven (7) other functions; and
- That the Executive Mayor is entitled to protection and it is unacceptable that the Active Box did not notify the Executive Mayor or the Administration of the incident on the Executive Mayor's property the past weekend and only contacted SAPS.
