Bergrivier Municipality invites tenders for tender no: **8/3/29-2017 (MN150/2017)** for the Construction of the Driver's License Test Yard for Piketberg.

It is estimated that tenderers should have a minimum CIDB contractor grading designation of **5CE** or higher.

Only goods, works and services with a stipulated minimum threshold as applicable for local production and content will be considered as per Schedule 10.

All bids received shall be evaluated in terms of the Bergrivier Municipality's Supply Chain Management Policy, read with the Preferential Procurement Regulations of 2011. It is estimated that the 90/10 preference points system will be applicable. Tenders will be evaluated in terms of price and preference.

Bid documents and specifications are available at a cost of R400 per set and can be collected from Ms M van Zyl at the Bergrivier Municipal Offices. Only cash payments or cheques made out in favour of Bergrivier Municipality will be accepted. The tender deposit must be paid before a hard copy of the tender document will be issued.

Tenders may only be submitted on the original tender documentation that is issued from Bergrivier Municipality.
