#### 1 BACKGROUND

##### SCOPE

Tenderers shall allow for the following:

The municipality shall not rent any equipment or bandwidth but an Service level Agreement will be entered into to provide maintenance and support on the installation. The municipality reserves the right to install additional sites when identified.

The Municipality will operate under the Independent Communications Authority of South Africa (ICASA) license of the appointed service provider for the duration of the contract, while concurrently submitting an application to ICASA for an exemption license.

The offices detailed in the table below form part of the required network connectivity scope and must be connected in accordance with the specifications set out in this document. Prospective bidders are welcome to visit the respective sites to familiarize themselves with it.


