TENDER NR 8/3/57 – 2021 (MN 261 – 2021) CONSTRUCTION OF THE NORTHERN BOUNDARY WALL, PIKETBERG

Pursuant to the compulsory clarification meeting held on Tuesday, 24 November 2021, bidders must kindly note the following:

1. Removal of Trees

The existing trees alongside the northern boundary must be removed as well, and bidders must make provision for the removal in their pricing. It will include:

- the cutting of trees in a way that will ensure no damage or loss of life to adjacent municipal or private property, graves, staff, clients or visitors
- the removal of all branches and stumps in order to allow for the excavation of the trenches
- Comply with the Electricity Act, 1996 and the Occupational Health and Safety Act, No. 181 of 1993 relating to all clearance operations and clearance/ tree felling near any power lines
- Ensure compliance with the Occupational Health and Safety Act and the National Environmental management Act, No. 107 of 1998
- The contractor is responsible for providing the Personal Protective Equipment necessary and also the required training to all workers, contractors and/ or sub-contractors

2. Comprehensive Public Liability

- the public liability must not be less than R5 million

As a result, bidders must use the pricing schedule hereunder and ignore the previous one. This is a material condition, and failing to comply can render a bid non-responsive.
