The Contractor shall develop the detailed design of the Hybrid Off grid SSEG system with storage in full compliance with local and international standards related to electrical works and specifically PV works (where local codes are insufficient). The Contractor assumes full liability for the design and performance of the system. The design shall be performed in full compliance with SANS 10142-1, IEC 62619, NRS-097-2-1:2017, the South African Grid Code and all other local and international standards related to electrical and specifically Battery Energy Storage Systems (BESS). The design shall furthermore be performed according to the technical specifications and the relevant Municipal, national, and international standards.

The designs shall include, but not be limited to, the following:

- All PV Mounting Structures including foundation.
- Solar modules including DC Cabling and earthing.
- Inverters, Optimizers and/or micro-inverters.
- All Combiner Boxes.
- Batteries and Battery Management System (BMS, EMS etc.).
- Grid connection/Point of Coupling including Changeover/Transfer Switches.
- Grounding of all equipment and lightning protection as required.
- Communication cabling and Monitoring Systems.
- Distribution boards

The hybrid system is to provide continuous, reliable, and uninterruptable power to existing operations during normal hours as well as power outages. The system shall be capable of supplying a minimum of 200W continuous power @ 25°C to the load under all circumstances. The system shall have a storage capacity of 2,56kWh @ 80% DoD. The system shall be capable to produce the full 200W of power. The system shall be capable of supplying a minimum of 250W (125% of rated output) for 30 seconds, and a transient overload of 200% for a period of 250 milliseconds.

During normal operation the system shall be charged by Solar PV power to ensure it is in a ready state in the event of a power failure. If the output of the Solar PV plant exceeds the load requirements, excess energy shall be used to charge the batteries.

The panels to be used shall be reliable Tier 1 modules with a proven track record in performance. All modules supplied shall be of the same type and from a single manufacturer. The photovoltaic module technologies to be utilized can be either Monocrystalline Silicon, Polycrystalline Silicon or Bifacial/Graphene types.

The guaranteed module power output during the first year of operation should be a minimum of 97% of its rated output with a maximum linear degradation of -0.8% per annum from year 2 to year 25. The modules shall be certified as a minimum for the following:

- IEC 61215: Ageing of PV modules including for all forces of nature
- IEC 61730: Photovoltaic (PV) module safety Standards
- ISO 9001 Certified
- OHSAS 18001: Occupational Health and Safety

Modules shall carry a defect warranty of at least 5 years and a linear 25-year performance guarantee of 80%. The guaranteed linear degradation in performance of the solar panels output over a period of 25 years from delivery, stated as a percentage (%) of the rated output of the modules after years 1, 10, 20 and 25.

The Hybrid Inverter shall be certified and operate according to SANS 62109-1, IEC 62109-2, NRS048-2 and NRS 097-2-1. These functions shall include, but are not limited to, the following:

- Ensuring that the output waveform is within specified harmonic and flicker limits.
- Monitoring faults on the DC side (earth and insolation faults)

Inverters must be setup for an optimal hybrid application and shall include:

- DC Overcurrent and Surge Protection
- External DC Isolation Switch
- At least one MPP tracker
- An advanced system to allow power control and efficiency (maximum efficiency) must be at least 97% (excluding transformer)
- Communication/network connectivity for Remote monitoring and control capabilities
- Isolation fault detection & Anti-islanding
- Ability to start and stop function automatically
- Variable power factor setting
- The MPP voltages of the strings are to be verified to lie in the MPP voltage range of the inverter for temperatures between 0°C and 70°C. The maximum inverter input voltage is not to be exceeded at temperatures of -10°C.

The ratio of the input DC power to output AC power must be between 80% and 120% at STC. An IP protection class of IP65 is required for outdoor mounting and an IP grade of at least 21 is required for indoor mounting of the inverters. If inverters are installed outdoors, they must be protected from direct sunlight

All inverters supplied shall have a warranty of at least 10 years. 



GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT

General Conditions of Contract

1. Definitions

- 1. The following terms must be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.

GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT

- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and

not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price, which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.

- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.

- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security,

maintenance and other such obligations of the supplier covered under the contract.

- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.
- 2. Application
 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
 - 2.2 Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.
 - 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions must apply.

- **3. General** 3.1 Unless otherwise indicated in the bidding documents, the purchaser must not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
 - 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.
- **4. Standards** 4.1 The goods supplied must conform to the standards mentioned in the bidding documents and specifications.

consent, disclose the contract, or any provision thereof, or any
specification, plan, drawing, pattern, sample, or information
furnished by or on behalf of the purchaser in connection

supplier in the performance of the contract. Disclosure to any

such employed person must be made in confidence and must extend only so far as may be necessary for purposes of such performance.

- 5.2 The supplier must not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 must remain the property of the purchaser and must be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier must permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
- **6. Patent Rights** 6.1 The supplier must indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

With reference to the judgment of the Supreme Court of Appeal case number 937/2012 Dr JS Moroka Municipality vs. Bertram (PTY) Limited 2013 JDR 2728 SCA the following:

"In our view the judgment supports the proposition that a Municipality determines the requirements for a valid tender and a failure to comply with the prescribed conditions of tender will result in such tender being disqualified as it would not be an 'acceptable tender' as defined in the Preferential Procurement Policy Framework Act 5 of 2000 unless the prescribed conditions are immaterial, unreasonable or unconstitutional.

Therefore, provided that the relevant tender document makes provision for <u>an original tax clearance certificate</u> <u>and/or any other certificates/documents</u> as a prescribed minimum prerequisite and/or peremptory requirement in order for such tender to be considered an 'acceptable tender' and to pass the threshold requirement for consideration and evaluation, and a tenderer fails to provide same, the Municipality would be within its rights to disqualify such tender/tenderer."

Therefore BERGRIVIER Municipality will with immediate effect exclude all offers from bidders if the required documentation is not handed in/or attached with the original bidding documents.
