**WESTERN CAPE MOBILITY DEPARTMENT  
DRAFT REGISTRATION AND LICENCE FEES FOR MOTOR VEHICLES  
REGULATIONS, 2026**

The Provincial Minister of Mobility, in terms of section 7 of the Western Cape Provincial Road Traffic Administration Act, 2012 (Act 6 of 2012), intends to make the regulations set out in the Schedule.

**SCHEDULE****Definitions**

1. In these regulations, any word or expression defined or used in the National Road Traffic Act, 1996 (Act 93 of 1996), or in the regulations made under that Act, has the same meaning, unless the context indicates otherwise.

**Registration and licence fees**

2. The fees payable in respect of the registration and licensing of motor vehicles in the Province are as set out in the Annexure.

**Repeal**

3. The regulations published under Provincial Notice 81/2025 in *Provincial Gazette* 9101 dated 11 July 2025 are repealed.

**Commencement**

4. These regulations come into operation on 1 July 2026.
